

NOTIFICATION

In exercise of the powers conferred by paragraph 25 of the Tripura (Courts) Order, 1950, the Governor is pleased to direct that one new court of Additional District & Sessions Judge is constituted for the West Tripura Civil District & Sessions Division, which shall hold it's sitting at Sadar Sub Division (Agartala) under West Tripura District, with a view to achieve a leaner judiciary by using existing infrastructure, officers and staff. 
The notification shall take immediate effect.
