

The Government of Tripura is further pleased to order that such investitures shall remain inoperative so long as the aforesaid Judicial Officers, so invested with, are posted or remain on deputation to the State Government or the Central Government or any other pure administrative authority or body, where the invested Judicial powers are not required to be exercised or until appropriate judicial posting are made in respect of them by the Hon'ble High Court.

3. This shall take immediate effect and remain in force until further Notification made in this respect and on this behalf.
