

3. The quotations should be furnished in proper pad of the Printer duly signed by the Proprietor/Manager.
4. The quotation should be accompanied with the following valid documents -
  - (i) ITC, PTC Certificate.
  - (ii) Factory Registration Certificate.
  - (iii) Trade Licence issued by the Municipal Council, Agartala.
  - (iv) Certificate of experience/appreciation issued by any other Government Department of Tripura.
5. The Printer, whose quotation will be accepted shall be bound to supply the printed materials **within 10<sup>th</sup> August, 2011.**
